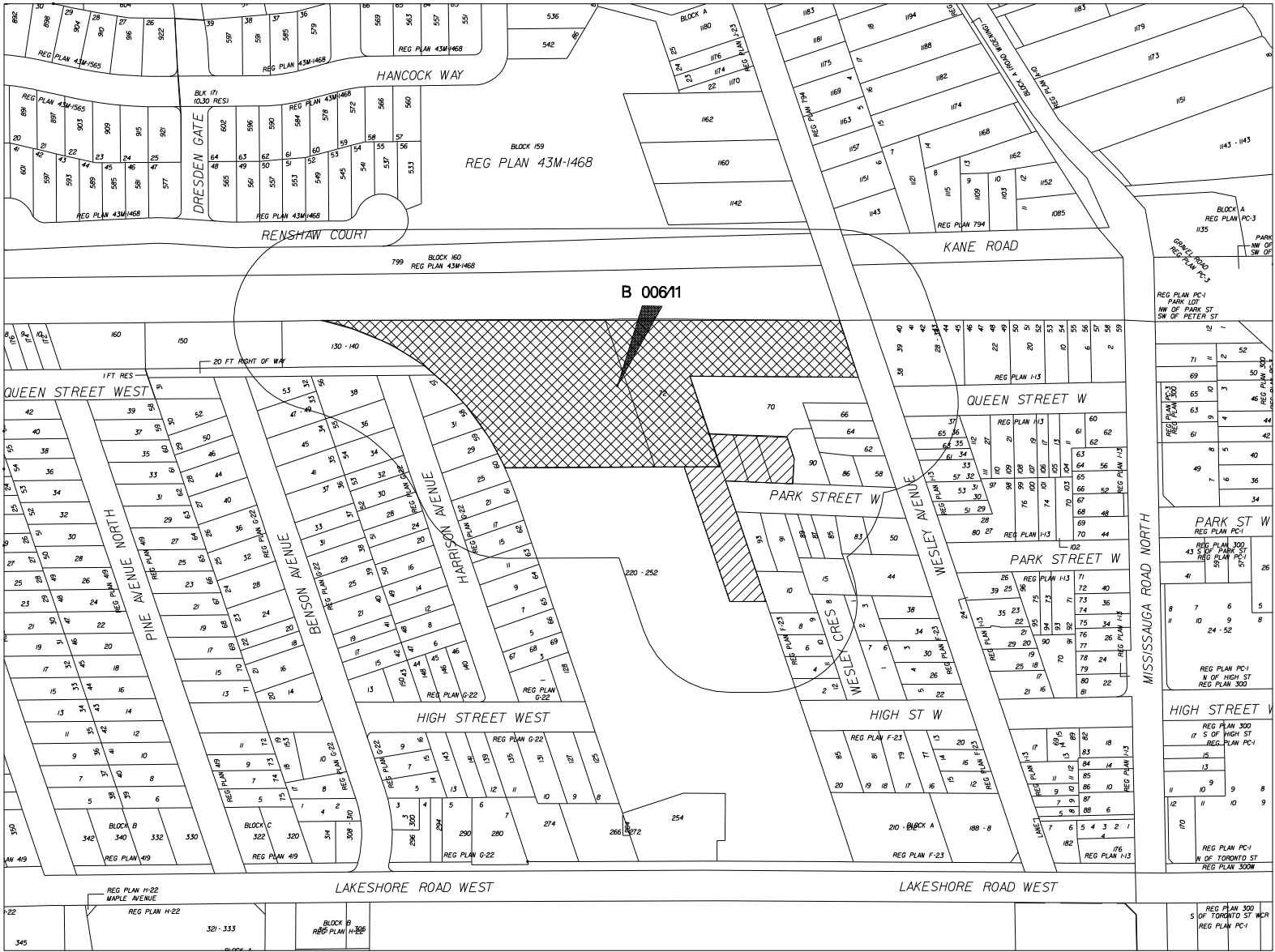
## COMMITTEE OF ADJUSTMENT NOTICE OF APPLICATION

**IMPERIAL OIL LIMITED** is the owner of Part of Lot 9, Range 1, C.I.R., located and known as **72 WESLEY AVENUE**, zoned E2-58, Employment and H-C2-10, Commercial (Holding). The applicant requests the consent of the Committee to the conveyance of a parcel of land having a frontage of approximately 39.62 m (129.98 ft) and an area of approximately 2 ha (4.94 ac). If it is inconvenient for you to attend the hearing, signed written submissions shall be accepted by the Secretary-Treasurer prior to or during the hearing and such written submissions shall be available for inspection by any interested person. If you wish to be notified of the decision of the Committee in respect of the proposed consent, you must make a written request to the Committee of Adjustment requesting notification of the Committee's decision or attend the hearing in person or by counsel or you will not be entitled to receive a copy of the Committee's decision or any subsequent correspondence relating to any future Ontario Municipal Board proceedings. If a person or public body that files an appeal of the decision and/or any condition imposed by the Committee of Adjustment in respect of the proposed consent, does not make a written submission to the Committee of Adjustment before it gives or refuses to give a provisional consent, then the Ontario Municipal Board may dismiss the appeal. Requests for deferment of hearing date, by the applicant or representative, must be for reasonable cause and an alternative hearing date will be at the discretion of the Committee. Failure of the Applicant or their Representative to appear at any hearing may result in the automatic dismissal of the application.
